

EEOC - KNOW YOUR RIGHTS: WORKPLACE DISCRIMINATION IS ILLEGAL. Know Your Rights: Workplace Discrimination Is Illegal. The U.S. Equal Employment Opportunity Commission (EEOC) enforces federal laws that protect you from discrimination in employment.

WORKERS' COMPENSATION Notice to Employees. Washington State Department of Labor & Industries. It's the law! Employers must post this notice where employees can read it.

FMLA - FAMILY AND MEDICAL LEAVE ACT. Your Employer Rights Under the Family and Medical Leave Act. What is FMLA leave? The Family and Medical Leave Act (FMLA) is a federal law that provides eligible employees with job-protected leave for qualifying family and medical reasons.

DISCRIMINATION Washington State Law Prohibits Discrimination in Employment. PROTECTED CLASSES: Race, Color, National Origin, Sex, Creed, Disability, etc.

SELF-INSURED WORKERS' COMPENSATION Notice to Employees. Washington State Department of Labor & Industries. It's the law! Employers must post this notice where employees can read it.

USERRA - UNIFORMED SERVICES EMPLOYMENT AND REEMPLOYMENT RIGHTS ACT. YOUR RIGHTS UNDER USERRA: THE UNIFORMED SERVICES EMPLOYMENT AND REEMPLOYMENT RIGHTS ACT. USERRA protects the job rights of individuals who voluntarily or involuntarily leave employment positions to undertake military service.

EMPLOYEE POLYGRAPH PROTECTION ACT. EMPLOYEE RIGHTS | EMPLOYEE POLYGRAPH PROTECTION ACT. The Employee Polygraph Protection Act (EPPA) prohibits private employers from using lie detector tests for pre-employment screening or during the course of employment.

DOMESTIC VIOLENCE RESOURCES. No one ever deserves to be mistreated. Abuse is a pattern of behavior that one person uses to gain power and control over another.

UNEMPLOYMENT INSURANCE. To apply for unemployment, you will need: Social Security number, Names and addresses of employer, Dates you started and stopped working for each employer.

PAID FAMILY AND MEDICAL LEAVE. Paid time off. Peace of mind. Paid Family and Medical Leave provides paid time off when a serious health condition prevents you from working, when you need to care for a family member or a new child, or for certain military-related events.
